

SUMMARY ANNUAL REPORT FOR HOPE COLLEGE EMPLOYEE BENEFIT PLAN

This is a summary of the annual report of the Hope College Employee Benefit Plan (Employer Identification Number 38-1381271, Plan Number 501) for the plan year 07/01/2020 through 06/30/2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Hope College has committed itself to pay certain medical claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with Ulliance, Inc., The Lincoln National Life Insurance Company, ACE American Insurance Company and Blue Cross Blue Shield of Michigan to pay certain life, accidental death and dismemberment, dental, long-term disability, employee assistance program, business travel accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 06/30/2021 were \$695,721.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 06/30/2021, the premiums paid under such "experience-rated" contracts were \$376,723 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$327,088.
